Best Girl- 1 year & a day to 18 months

Best Boy- 1 year & a day to 18 months

Best Boy- 18 months & a day to 2 years

Rules for Eligibility:

- 1. Babies cannot be 1 day younger than 6 months or 1 day older than 2 years the DAY of the Show.**
- 2. All babies must be residents of Shelby County.**
- 3. All babies must be pre-registered.**
- 4. Babies will be judged on cuteness (looks), appearance, and personality only. Judges will be from outside Shelby County.**
- 5. Attire: Summer play clothing only-no suits, no tux, or pageant type dresses.**
- 6. Winners will be announced immediately following the judging of that age category.**
- 7. The next class will begin 5 minutes after the previous class has exited the stage.**
- 8. \$10 Entry fee per contestant is non-refundable.**
- 9. Every baby will receive a participation ribbon. Trophies will be awarded to the 1st place winner, ribbons to the 2nd and 3rd place winners.**
