### **Rules:**

1. Entries close June 11. Stall fees must accompany entries at this time. Post entries will be accepted for an additional \$5.00 per class entered
2. No horse or rider will be eligible to compete who has not been properly entered.
3. All horses must have a current negative coggins test and a health certificate issued within the past 120 days with a temperature on each animal.
4. Exhibitors are notified that any act of discourtesy by them, their riders, drivers, grooms or agents shall disqualify their entry and the owners shall forfeit his entry fees and other charges including all winnings at this show. The horse show committee reserves the right to rule in such cases.
5. A protest must be signed and taken to the secretary's office accompanied by a \$250.00 deposit within 48 hours of the occurrence of the alleged violation. If the protest is sustained, the deposit shall be forfeited to the Shelby County Fair and Horse Show. In the event the protest is sustained the entry standing next in award will be moved up accordingly.
6. The Horse Show Committee reserves the right to interpret these rules and to rule on any other questions that may arise without damages or recourse of any kind.

7. The gate of the show ring will be closed two minutes after the first horse enters the ring. Any exhibitor not in the ring at that time will not be admitted.

#### No Solicitation Policy

We certainly hope that you will honor and respect our no solicitation policy. During the Shelby County Fair & Horse Show we ask that there is no outside solicitation of any kind on the show grounds; including but not limited to solicitation of photographs, food, clothing, videos, jewelry, tack, etc. without a written contractual agreement with the Shelby County Fair and Horse Show management. We have contracted with a wonderful staff of officials and vendors and feel that this policy will help ensure that we continue to have a successful event.
